- What is the purpose of the Endowment?

An endowment is a permanent fund designated for a specific purpose, the principal of which is held in perpetuity. The purpose of the St. Vincent de Paul School Endowment is to provide for student tuition assistance and affordable Catholic education. The money that you donate today will continue to be used years from now. Interest from your contribution will compound and generate income for our students for generations to come.

Although the Endowment will someday provide a stream of tuition assistance revenue, the value of the endowment has not reached the \$1,000,000 in endowed funds required before it can be drawn upon.

- Endowment funds will keep the cost of Catholic education affordable.

Over the past ten years, as operating costs have increased, so have tuition assistance needs for parish families. Total tuition assistance grants needed have increased \$10,000 in the year 2000 to over \$95,000 this school year. Over 15% of our students now receive financial support. Since tuition remains the primary source of income for our school, keeping it within an affordable range will keep our school open and full in the future.
